11 a stipulation is not submitted, the child support obligation established
12 in this order will continue until such time as all children who are the
13 subject of this order reach 18 years of age or, if the youngest child
14 who is subject to this order is still in high school when he or she
15 reaches 18 years of age, when the child graduates from high school or
16 reaches 19 years of age, whichever comes first. Unless the parties
17 agree otherwise in a stipulation, any modification made pursuant to a
18 motion to modify the order will be effective as of the date the motion
19 was filed.
