A meeting has been scheduled for the Law Library Board of Trustees on Wednesday, February 6, 2019, at 12:00 PM in the Robert Z. Hawkins Boardroom in the Washoe County Law Library. The library is located in room 101 on the first floor of the Courthouse at 75 Court Street, Reno, Nevada 89501.

NOTE: Items on the agenda may be taken out of order; combined with other items; removed from the agenda; moved to the agenda of another later meeting; or may be voted on in a block. Items with a specific time designation will not be heard prior to the stated time, but may be heard later.

The Robert Z. Hawkins Boardroom is accessible to the disabled. If you require special arrangements for the meeting, call the Law Library at (775) 328-3250, at least twenty-four hours prior to the meeting.

Time Limits. Public comments are welcomed during the Public Comment periods for all matters, whether listed on the agenda or not, and are limited to three minutes per person. Additionally, public comment of three minutes per person will be heard during individual action items on the agenda. Persons are invited to submit comments in writing on the agenda items and/or attend and make comment on that item at the Board meeting. Persons may not allocate unused time to other speakers.

Responses to Public Comments. The Board of Trustees can deliberate or take action only if a matter has been listed on an agenda properly posted prior to the meeting. During the public comment period, speakers may address matters listed or not listed on the published agenda. The Open Meeting Law does not expressly prohibit responses to public comments by the Board of Trustees. However, responses from Board members to unlisted public comment topics could become deliberation on a matter without notice to the public. On the advice of legal counsel and to ensure the public has notice of all matters the Board of Trustees will consider, Board of Trustees may choose not to respond to public comments, except to correct factual inaccuracies, ask for staff action or to ask that a matter be listed on a future agenda. The Board of Trustees may do this either during the public comment item or during the following item: "Board Comment – Limited to Announcements or Issues for Future Agendas".

December 5, 2018

1. Roll Call at 11:01 a.m.

Board Members present:

Honorable Connie Steinheimer, Honorable Chuck Weller, Honorable Scott Freeman, Michael Kattelman, Clayton Brust, Kathi Lutsch, Stephen Hollandsworth, and Cortney Young. Also, present was Self Help Center and Law Library Program Manager, Emily Reed.

2. Public Comments

3. Approval of Minutes from Board Meeting of September 5, 2018:

Honorable Connie Steinheimer made a motion to approve, unanimous approval.

4. Update regarding the Law Library, including Lawyer in the Library Update, 2018 statistics on volunteers, attendance, and topics covered; Law Library Statistics for 2018, including statistics on number of patrons and usage:

The Law Library is doing well. To date, we have assisted 73 more patrons than last year. We have reduced the number turned away in family law. The number turned away in general law has increased by approximately 7 people (57 so far). Gary Silverman volunteered 9 times this year.

We have received a one-year grant from the WCBA for one addition Westlaw Next terminal (does not include all of the patron access plan, but does allow for users to get stated on their research when we are full).

5. Board Membership – Nomination and Selection of one attorney member and one non-attorney member*

Kathi Lutsch has applied for the non-attorney member.

Mike Kattelman has applied for the attorney member.

No other nominations.

Vote to ask County Commission to approve the nominations.

Clay Brust made a motion to approve, unanimous approval.

6. Discussion and possible action regarding Thomson Reuters print items purchased by the Law Library, whether to discontinue certain print items, and authorizing the Self-Help Center and Law Library Program Manager to negotiate the terms of and enter into a multi-year Thomson Reuters Library Management Arrangement for the purchase of print items.

Same items had zero usage over 3 years. Some very minimal usage. Removal of zero usage items = a savings of \$2,500 per year; approximately \$5,000.00 per year if discontinue all books identified by Mr. Reed. Will use savings for new books.

Honorable Chuck Weller made a motion to approve discontinuing all books with no use or minimal use, Honorable Scott Freeman seconded the motion. The Honorable Connie Steinheimer opposed and Mr. Kattelman, Mr. Brust, Ms. Young and Ms. Lutsch all voted in approval.
