The Board Chair may order the removal of any person whose statement or other conduct disrupts the orderly, efficient, or safe conduct of the meeting. Warnings against disruptive conduct may or may not be given before removal. The viewpoint of a speaker will not be restricted, but reasonable restrictions may be imposed upon the time, place and manner of speech. Irrelevant and unduly repetitious statements and personal attacks which antagonize or incite others are examples of speech that may be reasonably limited.

NOTE: Items on the agenda may be taken out of order; combined with other items; removed from the agenda; moved to the agenda of another later meeting; or may be voted on in a block. Items with a specific time designation will not be heard prior to the stated time, but may be heard later.

<u>Accessibility.</u> In compliance with the Americans with Disabilities Act, those requiring accommodation for this meeting should notify the Washoe County Law Library at (775) 328-3250, 24 hours prior to the meeting.

<u>Time Limits.</u> Public comments are welcomed during the Public Comment periods for all matters, whether listed on the agenda or not, and are limited to three minutes per person. Additionally, public comment of three minutes per person will be heard during individual action items on the agenda. Persons may not allocate unused time to other speakers.

<u>Public Comment.</u> Members of the public may submit public comment by logging into the ZOOM webinar listed above.

Responses to Public Comments. The Board of Trustees can deliberate or take action only if a matter has been listed on an agenda properly posted prior to the meeting. During the public comment period, speakers may address matters listed or not listed on the published agenda. The Open Meeting Law does not expressly prohibit responses to public comments by the Board of Trustees. However, responses from Board members to unlisted public comment topics could become deliberation on a matter without notice to the public. On the advice of legal counsel and to ensure the public has notice of all matters the Board of Trustees will consider, Board of Trustees may

choose not to respond to public comments, except to correct factual inaccuracies, ask for staff action or to ask that a matter be listed on a future agenda. The Board of Trustees may do this either during the public comment item or during the following item: "Board Comment – Limited to Announcements or Issues for Future Agendas."

Meeting Minutes

September 1, 2021

1. Roll Call

Board Members present:

Honorable Connie Steinheimer, Honorable Tamatha Schreinert, Mike Kattelman, Cortney Young, and Patricia Halstead

Honorable Scott Freeman and Kathi Lutsch were not present.

Also present were:

Sarah Bates, Law Librarian; and Lindsay Liddell, Deputy District Attorney and Trenton Ross, Deputy District Attorney (Washoe County District Attorney's Office)

2. Public Comments:

None.

3. Law Library Board of Trustees Deputy District Attorney reassignment and introduction (Lindsay Liddell & Trenton Ross).

Ms. Liddell will be leaving as the Deputy District Attorney for the Board and she will be replaced by Mr. Ross.

**Meeting began at 11:50 a.m. and Audio and Video recording began at 12:07 p.m.

4. Approval of Minutes from Board Meeting of June 2, 2021. For Possible Action.

Motion to approve the minutes was made by Trustee Kattelman and seconded by Judge Schreinert.

No discussion was had.

Minutes approved unanimously.

5. Update regarding the Law Library, including recent projects, grants awarded, new online catalog (Koha), Lawyer in the Library, and 2021 statistics.

Law Library is down to four members. Ms. Mansfield, Senior Law Library Assistant, resigned June 3 to take a position with Department 15. Her replacement will start September 20, 2021. Natalie Villegas, Law Library Assistant III, resigned on August 27. Applications are being accepted for this position.

Due to COVID-19 restrictions, staff at the library is splitting their time between the library and working remotely (2 remote and 2 at the library). Library was able to open in July for in person visits. However, Lawyer in the Library remains virtual at this time with access to computers still available in person in the library. Social distancing and masks are required when in the library. Computers are placed

in a socially distanced manner. Sneeze guards are still being used in the library and air purifiers are being utilized.

This year the library was granted \$4,500.00 from the Nevada State Library Evolving Needs Grant Award which helped with mobile book return, new library cards with key tags, and RFID tags. The Nevada State Library LSTA American Rescue Plan Grant Award was given to the library in the amount of \$20,000.00 which will be used to expand the Lexus digital collection. As part of this the library will end up with 53 new print books in addition to the digital materials. Finally, a donation from the David Hamilton trust was also given to the library.

The new Koha system is now in place and training was completed by the staff. This system is much more user friendly and staff is currently designing the catalogue for use. A brief demonstration of the new catalogue was given to the Board.

Judge Schreinert inquired if the general public can search the catalogue. Ms. Bates informed the Board that once you have a card then you can make requests for resources.

Judge Steinheimer asked how we are acknowledging the grants. Ms. Bates stated that we are doing so in the Writ.

No action taken.

6. Status update from Mike Kattelman about the informational video project about the court system and court procedure for the public, and possible action regarding use of video scripts as a guide with room for improv or use of the scripts to directly match video content. For possible action.

Trustee Kattelman updated the Board on the progress which included work with the producer to fine tune the scripts. Board input is requested related to the manner in which the scripts are read. Some topics do better with a question and answer in free flow fashion vs. actual scripted content. Judge Steinheimer stated that she didn't necessarily need a word for word script and asked how the Board would address any issues with the actual content if they arose. Judge Schreinert agreed and Trustee Kattelman informed the Board that they would still have review of the outline. Trustee Halstead agreed.

Trustee Kattelman noted that the funds that the library has received from the Family Law Section of the State Bar have not yet been used for the project.

Judge Steinheimer thanked Trustee Kattelman for his efforts with respect to the project.

No action taken.

7. Discussion and possible action regarding whether December 1 meeting should be held in person or virtually via Zoom, and whether Annual Lawyer in the Library Volunteer recognition event should be held this year. For possible action.

The Governor signed AB 253 and as a result, in person meetings are not required and the Board can continue to meet virtually. Judge Steinheimer asked Ms. Bates if she had a preference as to in person or virtual. Ms. Bates stated that she would lean toward not being in person given the current restrictions due to COVID-19.

Judge Steinheimer asked for input from the Board and suggested possible alternatives such as doing the ceremony via Zoom. Judge Schreinert acknowledged successes of virtual events and agreed that keeping it virtual is a prudent approach. Trustee Young agreed with Judge Schreinert's comments and suggested that

a way the Board could get involved may be to let our volunteers know we appreciate their efforts via a letter or card. Trustee Kattelman agreed that a virtual event may be a good idea to recognize the volunteers. Trustee Halstead agreed with the prior comments.

Judge Steinheimer inquired as to the past caterers used for the event and discussion was had about providing lunch to our volunteers and logistics regarding the same. Further discussion was had about date and time of the ceremony and who may be able to attend of the Judges and Justices.

Judge Steinheimer suggested that if the Board moves forward with the event virtually in December that another meeting be set for the Board to work through the details.

Kattelman made a motion that we have the celebration on December 1 if there are no conflicts and that it be done via a Zoom meeting. The motion included having a restaurant deliver lunch to our top volunteers and to provide a gift card to those other volunteers. Judge Schreinert seconded the motion.

Discussion was had about Cherry Bomb doing a box lunch for those top volunteers as well as Starbucks cards to add. Judge Schreinert noted that it should be a virtual meeting not a webinar so that all can be seen.

Trustee Kattelman amended the original Motion to include the items in the discussion.

Motion as amended passed unanimously.

Re: meeting of the Board on December 1. Judge Steinheimer inquired as to the Board's preference on a meeting date and whether it made sense to have the meeting the same day as the ceremony.

Motion was made by Judge Schreinert to have the meeting virtually and that it be a date prior to the ceremony. The proposed date is November 17. Trustee Halstead noted that the Probate Bar lunch is that day at noon. Discussion was had about changing the date and/or time of the Board's meeting to accommodate that. November 16 or 18 were proposed as alternate dates.

Judge Schreinert amended the motion to be held virtually Tuesday November 16 at noon. Trustee Kattelman seconded. No further discussion was had. This is a rescheduling of the December 1 board meeting.

Motion passed unanimously.




Database usage
