On May 8, NNWLA will have 20 attorney volunteers at the Law Library for their Law Day Lawyer in the Library event.

Emily spoke at the Nevada Early Intervention Services Support Group regarding Law Library services.

The Law Library had its first Eddy House program where a volunteer attorney spoke to homeless youth.

Ms. Young from the District Attorney's office volunteered to help with the Eddy House program.

Donation not to exceed \$2,979.96 to send one employee to the American Association of Law Libraries Annual Conference in Washington D.C. Dates are July 13, 2019, to July 17, 2019.

# Memorandum of Understanding and Agreement To extend the Utah Regional Federal Depository Library (Utah State University Libraries) to include services for the Nevada Federal Depository Libraries

This Memorandum of Understanding and Agreement ("Agreement") is entered into by Utah State University Libraries (USU) and the Nevada Federal Depository Libraries: Great Basin College Library, (0356A), Las Vegas Library (0353B), Washoe County Law Library (0353A), Nevada State Library (0352), University of Nevada, Reno (0353), Wiener-Rogers Law Library (0355B).

**Whereas**, USU and Nevada Federal Depository Libraries participate in the Federal Depository Library Program; and

**Whereas**, participating FDLP libraries in Nevada have been without a Regional Depository since June 2011; and

**Whereas,** Nevada Depository Libraries cannot fully participate in the Federal Depository Library Program without a Regional library; and

Whereas, USU is a current Regional depository with similar collection focuses; and

**Whereas**, the Federal depository libraries in Utah approve of this multi-state regional arrangement; and

**Whereas**, this Agreement was provided in draft to the United States Superintendent of Documents for review and the Superintendent has indicated support to its terms;

Now therefore, in consideration of the mutual covenants, promises, and representations made herein, the Parties hereto agree to the following:

- USU will assume the responsibilities and duties of a Federal Regional Depository Library for the Nevada Federal Depository Libraries, including the following responsibilities and duties:
  - a. Routine monitoring of disposal lists from all Federal Depository Libraries in Nevada.
  - b. Share offers lists with Federal Depository Libraries in Nevada using the same process used to share the lists with Federal Depository Libraries in Utah.
  - c. Provide reference services to Federal Depository Libraries in Nevada, after the Nevada State Library, Archives and Public Records (NSLA) and the Mathewson-IGT Knowledge Center, University of Nevada, Reno (UNR) have exhausted their efforts to provide the reference service.
  - d. Provide interlibrary loan/resource sharing access (ILL) to all tangible publications as considered prudent according to physical condition and replacement value.

- This applies to all the Federal Depository Libraries in Nevada. USU standard interlibrary loan/resource sharing procedures will be followed.
- e. Facilitate training initiatives to share expertise within the depository community and participate in public awareness/outreach campaigns to promote federal government publications to Depository Libraries in Nevada.
- f. Provide mentoring and build relationships with librarians at Depository Libraries in Nevada.
- g. Facilitate weeding, collection development, and cataloging processes at the Depository Libraries in Nevada as outlined by Federal Depository Library Program guidelines. If a selective library is interested, the Regional Coordinator is available to offer guidance on collection development toward a comprehensive Regional collection.
- h. Maintain files on the selective depository libraries in NV.
- i. As appropriate, the Regional coordinator will facilitate assessment via a biennial survey about the MOU and how its provisions are implemented.
- Nevada Federal Depository Libraries will assume the responsibilities and duties of Federal selective depository libraries under USU, including the following responsibilities and duties:
  - a. Maintain public access to depository materials and provide the equipment to view publications in non-print format.
  - b. Follow the disposition of materials instructions and processes of USU.
  - c. When a library finds a desired publication on the Utah/Nevada offers list, it will work directly with the library holding the publication to obtain it.
  - d. When unable to answer a reference question involving federal documents, refer the question to NSLA and UNR before referring the question to USU.
  - e. Provide ILL access to all tangible publications as considered prudent according to physical condition and replacement value. Individual library standard ILL procedures will be followed. ILL access applies to requests from USU and all Nevada and Utah Federal Depository Libraries.
  - f. Participate in mentoring and professional development opportunities as time permits.
  - g. Maintain statistics of collection use or reference transactions according to individual library policies, procedures, and/or standards, if already in existence.

#### 3. Endorsements

- a. Provisions do not conflict with the Legal Requirements & Program Regulations of the Federal Depository Library Program (LRPR).
- b. Any new selective depository library designations in Nevada will be subject to this agreement.
- c. This agreement is subject to biennial review and does not preclude the future designation of a Federal Regional Depository in Nevada subject to 90 days' notice to dissolve the agreement.
- d. The establishment of the Utah/Nevada multi-state regional was reviewed and approved by a Senator from each state.

- 4. Modification of the agreement is subject to the request of one of the signatories.

  Modifications will be ratified by all libraries under the agreement before taking effect.
- 5. The Regional Coordinator shall be designated by the administration of USU Libraries. At the time of this MOU, the Regional Coordinator is:
  - a. Jennifer Kirk, Assistant Librarian, Merrill-Cazier Library, 3000 Old Main Hill, Logan, Utah 84322, jen.kirk@usu.edu, 435-797-8033
  - b. Contact information for the current Regional Coordinator shall always be up-to-date/available via the FDLP directory and GPO contacts.
- 6. The contact for the selective depository libraries in Nevada are the depository coordinators, as identified in the Federal Depository Library Directory.
- 7. This agreement is effective as of the date of signature by all authorized representatives indicated below.
