21 **ORDER GRANTING RTC'S *EX PARTE* MOTION FOR ALTERNATIVE SERVICE OF**
22 **PROCESS ON DEFENDANT SAVEWAY MOTORS, INC.**

23 The Court has reviewed RTC'S *Ex Parte* Motion for Alternative Service of Process on
24 Defendant Saveway Motors, Inc. filed by Plaintiff RTC. The Court finds that, pursuant to NRCP
25 4.2(c)(3)A), RTC has presented facts demonstrating its good faith attempts to locate and serve
26 Saveway Motors, Inc. and has adequately explained why service on Saveway Motors, Inc., cannot
27 be made. RTC has also provided the Court with the last known address of Saveway Motors, Inc.'s
28 sole officer and director, Michael Chemor and the Court is satisfied that Mr. Chemor cannot be
located at that address. Therefore, good cause appearing,

1 IT IS HEREBY ORDERED that, pursuant to NRC 4.2(c)(3)(B), service on Saveway
2 Motors, Inc., service shall be made by:

- 3 (1) delivering a copy of the summons and complaint to the Nevada Secretary of State or his
4 or her deputy; and

6 (2) posting a copy of the summons and complaint in the office of the clerk of this Court.

8 (3) Mailing a copy of the summons and complaint via certified mail to Michael Chemor at
9 his last known address: 2070 Mill Street, Reno, NV, 89502.

10 Pursuant to NRC 4.2(c)(3)(E), defendant Saveway Motors, Inc. must serve a responsive
11 pleading within 21 days after the later of: (i) the date of service on the Nevada Secretary of State
12 and posting with the clerk of the court; or (ii) the date of the first mailing of the summons and
13 complaint to the last-known address of Michael Chemor.
